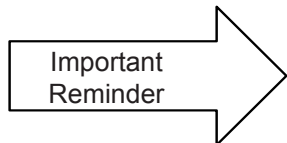

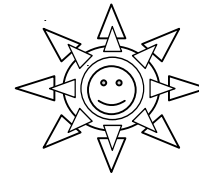


Important Parking Information

There is no charge for day of show parking. However, you will need to park on American Way (south side of site) only. Overnight parking on side streets is prohibited by Claremont City Ordinance. Do not park in the hotel lot if you are not a hotel guest.

Overnight RV Parking is limited to 10 spots. The rate is \$35.00 + tax per night. Check in at hotel front desk to register and pay. A parking permit will be issued and instructions where to park given. All vehicles must be fully self contained and include a fire extinguisher. GENERATORS MAY ONLY BE OPERATED AFTER 9:00 AM AND MUST BE SHUT DOWN AT 8:30 PM. This is a Claremont City Ordinance.

- Do not exercise your dogs on hotel grounds if you are not a hotel guest. There is sufficient area on the show grounds to exercise your dog and always remember to clean up after your dog! Thank you.
